- The project must advocate economic approaches that recognize natural resources and our environment as capital assets.
- Promote multidisciplinary, whole system, integrated and multi-objective goals in all phases of project planning, design, construction, operations, and decommissioning.
- The project may consider reduction of vulnerability to natural, accidental, and willful hazards to be part of sustainable development.
- The project should contribute to the well being of people and communities.
- Each project's affect (positive/negative) on society and the environment must be considered.
- Either the project or the headquarters of the prime design or construction firm must be located within the area of the Southeastern Michigan Branch.
