#### **AWARD REQUIREMENTS:**

#### Historical Civil Engineering Landmark Award

- The site must be officially nominated by an ASCE branch.
- The site shall have civil engineering significance.
- Size or technical complexity of design/construction is not sufficient in itself to qualify for an award.
- Each site must have at least one unique feature.
- The site should be generally available for public viewing, although safety considerations or geographical isolation may restrict access.
- A nominated site should be at least fifty years old.
- The original structure should be substantially intact, although routine maintenance is expected.

- Black and white glossy photographs should be included for publicity releases.
- Include two color photos (.jpg format) for use at the awards luncheon and for press release.

### Outstanding Civil Engineering Achievement Award & Quality of Life Award

- Each branch may nominate up to three projects per award category.
- The project must be completed and put into service or be ready for use.
- Phased projects may be submitted upon completion of a particular phase or segment.
- No project or project segment may be renominated after having received an award.
- Resourcefulness in planning and in the solution of design problems should be evident.
- Include two color photos (.jpg format) for use at the awards program and for press release.

### Young Civil Engineer of the Year Award & Franklin D. Meyers Civil Engineer of the Year Award

- All candidates must be nominated through an ASCE branch (each branch is encouraged to have a branch award to complement the Michigan Section Award).
- Information provided should be as complete and accurate as possible.
- To be eligible to receive the Franklin D. Meyers award, the engineer nominated should be living at the time of his/her nomination and be a member of the Michigan Section, American Society of Civil Engineers.
- An engineer who has moved out of state may still be nominated for service during his/her residency in Michigan.
- Include two color photos (.jpg format) for use at the awards luncheon and for press release.



## HISTORIC CIVIL ENGINEERING LANDMARK AWARD NOMINATION FORM

If a branch nomination is approved for landmark designation by the Michigan Section, the branch will be expected to assume responsibility for the planning of an award ceremony at which the plaque will be presented to the owner.

## OUTSTANDING CIVIL ENGINEERING ACHIEVEMENT AWARD NOMINATION FORM



The Michigan Section ASCE annually presents the **Outstanding Civil Engineering Achievement Award** for a project that demonstrates the highest level of engineering skill and that "represents the greatest contribution to civil engineering progress and mankind." The project must exemplify an aspect of civil engineering, while it should demonstrate use of innovations in materials, technology, or construction methods. The project should contribute to the well-being of people and communities. The project or the headquarters of the prime design or construction firm must be located in Michigan. Meritorious projects may also receive awards. The top three projects may be submitted for the National Outstanding Civil Engineering Achievement Award.

One award is given to the project and presented to the owner. Additional plaques may be ordered. In addition to the Outstanding Civil Engineering Achievement Award, Outstanding Civil Engineering Certificates of Merit will be given to submitted projects determined by the Awards Panel to be deserving of recognition.
