# Corridor Health: A Case Study

The Chiniak Highway MP 15-31 Project was originally programmed as a Resurfacing, Rehabilitation, and Restoration (3R) project for a 16 mile corridor. Given constrained funding, a method was needed to segment and prioritize improvements within the corridor into constructible projects. The design team utilized existing data sources to develop a Corridor Health Index methodology to analyze the existing roadway. Implementation of this methodology is expandable and flexible enough to apply to other projects, potentially saving time and money in overall project design and construction.
