Matt Talley is the Manager of Electric Transmission Engineering at Dominion Energy South Carolina.

Talley joined SCANA in 2013 and has worked in the electric transmission area over the course of his career. His recent positions include working as a design engineer, completing design work on transmission lines, and working as a field engineer and inspector on large, high profile transmission line projects.

He also is an active member of the transmission section of the Southeastern Electric Exchange and is currently serving as the chairman of the transmission section.

Talley earned a bachelor's degree in Civil and Environmental Engineering from The Citadel, The Military College of South Carolina in 2013. He is a registered professional engineer in South Carolina.

Abstract

This presentation will provide an overview of Dominion's Electric Transmission System including some of the unique challenges associated with transmission line design and construction in the diverse terrain and atmospheric and geotechnical conditions within South Carolina and the Dominion Energy South Carolina service territory.

Dominion Energy South Carolina's Electric Transmission Engineering department is responsible for the design and project management of all transmission line projects in the Dominion Energy South Carolina service territory. Additionally, Talley is responsible for right-of-way acquisition such as testifying as the expert witness in condemnation hearings and serving as the company's representative in 30(b)(6) depositions.
